ORDINANCE TO AMEND SEWAGE DISPOSAL ORDINANCE NO. 107

SEWAGE DISPOSAL

PLEASE TAKE NOTICE that the following proposed Ordinance was introduced at a meeting of the East Bay Charter Township Board on the 13th day of November, 2006, and that the same will be the subject of a public hearing and considered for passage by the East Bay Charter Township Board on the 11th day of December, 2006, at 6:30 p.m., at the East Bay Charter Township Hall, 1965 Three Mile Road, Traverse City, Michigan 49686. The Township telephone number is (231) 947-8647.

EAST BAY CHARTER TOWNSHIP ORDAINS:

Section 1

Ordinance No. 107 is hereby amended to add a new Section 25 titled: **Penalties**. The new section shall read as follows:

Any person, firm, association, corporation or other entity which shall violate any provision of this Ordinance shall be deemed to be responsible for a municipal civil infraction as defined by Michigan statute which shall be punishable by a maximum fine of \$500, along with costs which may include all expenses, direct and indirect, to which the Township has been put in connection with the municipal civil infraction. Costs of not less than \$9.00 or more than \$500 shall be ordered. A violator of this Ordinance shall also be subject to such additional sanctions and judicial orders as are authorized under Michigan law. Each day that a violation continues to exist shall constitute a separate violation of this Ordinance. Provision of this Ordinance may also be enforced by suit for injunctive relief. Failure to pay fines and/or costs shall subject the property in violation to a lien as provided for by law.

Civil Fines for Municipal Civil Infractions

1 st violation	= \$ <u>200.00</u>
2 nd violation within 3-year period*	= \$ <u>400.00</u>
3 rd violation within 3-year period*	= \$ <u>600.00</u>

*determined on the basis of the date of violation(s)

Section 2

This Ordinance shall take effect thirty (30) days after it is published.
