Please take notice that the East Bay Charter Township Planning Commission will hold a public hearing at a regular meeting on Tuesday, March 4, 2008 at 6:30 pm., in the Township Hall at 1965 Three Mile Road, Traverse City, Michigan, for the purpose of considering the following proposal:

Site plan review for a proposed expansion of the Northridge Condominiums located north of 3435 – 3453 Holiday Road, on parcels 176 and 177 of Sherwood Estates No. 4, (28-03-543-000-10 and 28-03-543-000-00). The property is zoned High Density Residential, HDR and the applicant proposes to expand the existing development with the addition of two, four-unit buildings to be located on the northerly portion of the site. The proposed use is permitted by right in the High Density Residential District subject to site plan review pursuant to Section 820 of the East Bay Charter Township Zoning Ordinance.

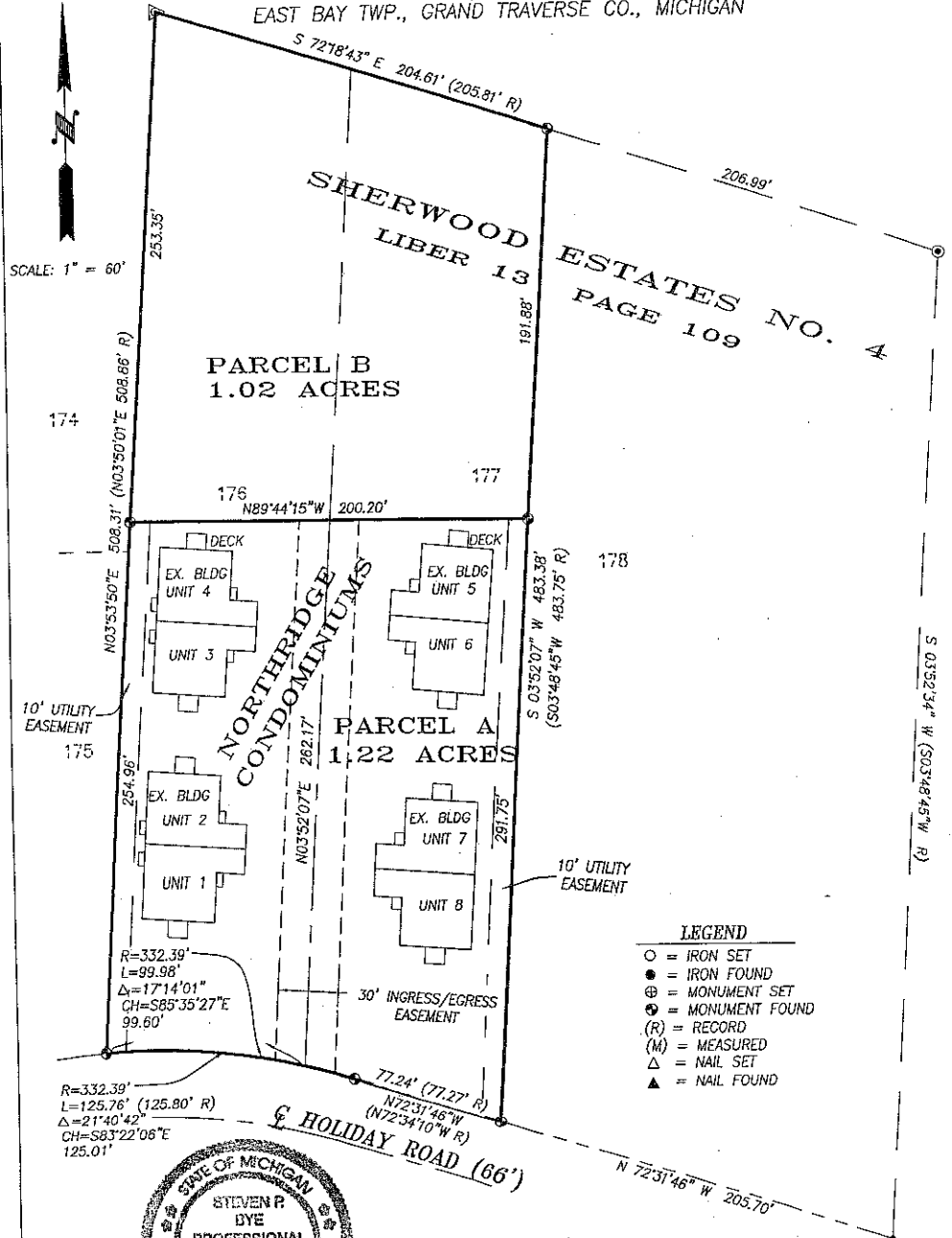

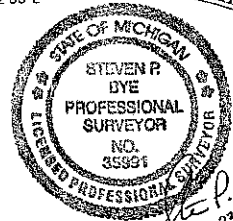
