Kudos as well to Bob and Viv Olson, who have taken on the challenge of organizing the whole day, every year! We had a beautiful day and enjoyed seeing all our friends and supporters. Some of the money that we raised has already purchased a "Pedi-mate" device for each one of our ambulances. The device will enable us to transport our infant and toddler patients even more safely to the hospital. Thank you all very much!

We continue with our monthly in service training for our staff. This keeps everyone updated with the latest things going on in

the EMS world.

We work very closely with our township Sheriff Community Police Officers. Currently, we have Deputy Shea and Deputy Jerome on board helping us out of station 9. Don't be surprised if they show up with us to give us a hand! Sometimes the extra pair of hands makes all the difference in the world!

We continue to partner in the "File for Life" program in our county. This is a program that allows you to list your medical history, medications, and/or emergency contacts on a "File for Life Form". We have the forms and the red pockets in our ambulances and at station 9. If you are interested, please contact us at station 9 – 947-0299.

Please watch out for pedestrians, cyclists, and kids everywhere! School will soon be

out and the weather is improving! We have had several car vs. pedestrian and bike type calls already. Be careful!

With all the crazy weather, don't forget that we have staff (fire and ambulance) at the station during the day time hours. We are available at station 9 to help you charge your electronics, provide water etc. or share a laugh to help you get through whatever may be going on! We have 911 response, office, and maintenance staff at Station 9 Monday-Friday, 8-5. In case of a major incident, the station will be staffed 24 hours as needed.

Grand Traverse Metro Authority

Hello from your fire department. This year continues to be busy one as we have seen our medical calls increased over last year by over 10% and we are on target to respond to over 3,000 calls for duty. We now have seven firefighters on duty at all times over our five fire stations. Last Friday the 27th of May, we opened our fifth new Fire Station #12. It sits in the Garfield Township's Silver Lake Park. This was the station that we received the American Recovery and Reinvestment Act (ARRA) grant to build. It is a beautiful and functional station and we welcome you all to the open house which will be held on July 23rd at 1:00.

This year will be the 10th anniversary of September 11. Our fire department will be holding a memorial service on Sunday the 11th of September. We welcome any citizen to attend. More to come on the place and time. Many of you have stopped by our fire station off of Three Mile road to see the World Trade Center artifact. It is a piece of a floor structure from the North Tower and weighs 3,100 pounds. It is now on a trailer and is being moved between fire stations and township offices. Look for it

at the Cherry Festival where it will be on display and in the parades. A permanent monument is planned for artifact later this fall. It is hopeful that we can put it in front of the fire administration officer at Three Mile and Parsons.

With summer comes the camp fire season. In East Bay Township you may have a campfire, but you are not allowed to burn unwanted materials, such as paper, trees, brush, leaves, grass, construction waste, and other debris. Please burn in a campfire ring and never leave your campfire unattended. When it is extremely dry and windy, use common sense and don't light a campfire. Remember, you are responsible for any fire you start that gets out of control.

Our stations are open for blood pressure checks Monday thru Friday 8-5. In East Bay Township we have a station at 110 High Lake Road near Courtade's Trading Post and off of Three Mile at 843 Industrial Circle. Have fun, be safe and enjoy the summer!

Assessing News

The Grand Traverse County GIS department is updating the "parcel layer" for the on-line township maps. As they create each map section, they may run into parcels that don't "fit". It's like a giant jigsaw puzzle in which all of the parcels of land should fit together nicely without overlaps and/or gaps. As they find parcels that don't fit, Susan Karakos, in our assessing office, may need to contact the property owners for assistance. Old surveys are especially helpful in clearing up any legal descriptions.

Planning & Zoning

Land Use Permits from the township are required for all types of construction activity, such as new homes, additions, garages, all decks, and sheds, including plastic and canvas sheds & carports, which are over 100 square feet. It is a good idea to check with the Zoning Office prior to construction to see what permits are needed. Land Use Permits, that are complete and filed, are usually issued within five working days, during regular business hours. Appointments for application review are available.

A Fee of \$300 is being imposed on projects, wherein, the owner or agent failed to contact the Zoning Inspector for a proper footing inspection. A zoning inspection is required for **all** permits both for non-footing construction and when an open trench for a footing is established (before concrete is poured). This inspection is for verification that the footing/placement is properly setback on the parcel to minimum zoning setback requirements. A call to the Zoning Inspector is required at least 24 hours prior to pouring footings or establishment of non-footing projects.

An Additional Fee of \$500 will be imposed on owners or agents, wherein, a Land Use Permit has not been obtained. There is a growing trend towards projects being started without obtaining the necessary permits before the project is undertaken. The township incurs unnecessary additional expense to obtain compliance from these individuals.

Real Estate Sign Violations: The Township receives many complaints regarding the proliferation of real estate signs. Most complaints are concerning the placement of the signs that are too close to the road, signs located off premises, or an increase in the size that is permitted. The East Bay Township Zoning Ordinance allows real estate signs as follows: **215.3.a; one non-illuminated two-sided sign advertising the sale or lease of the lot or building not exceeding six (6) square feet in area on any one lot.** These signs are also required to be set back so that they are outside of the road right of way. This usually means 33 feet from the centerline of the public road.

Off Premise Signs, such as directional and real estate signs are also prohibited. If signs are found to be in violation, the Township Zoning Inspector will remove the signs and store them at the expense of the sign owner.
